

### **Development Intiatives**

VCRIME: Violent Crime Reduction: Information, Messaging, and Engagment (BJA)

VCPI continued working with the Community Safety Collaborative (a national advisory board), conducted market research, and developed a national campaign, **My Voice**. **Our Community**. to raise awareness about the shared responsibility between community members and public safety professionals in reducing violent crime.

#### Measuring What Matters: Building Trust and Legitimacy (BJA)

VCPI completed and released the MWM e-Guide, an online resource for law enforcement agencies nationwide focusing on violent crime reduction, organizational culture, officer safety and wellness, and measuring and sustaining success.

#### BJA National Training and Technical Assistance (BJA NTTAC)

Through this program, VCPI provides crime prevention training to agencies requesting services. Additionally, VCPI continues to be an NTTAC Provider for BJA's Prosecution Assessment TTA Program.

### eLearning Curriculum for the National Association of School Resource Officers (NASRO)

VCPI completed development of an introductory-level eLearning course on School Resource Officer programs designed for a diverse national audience of community stakeholders involved in, or seeking to be part of, school safety efforts.

### **Development Intiatives**

#### VCPI eLearn Center (VCPI)

VCPI expanded its support of the public safety community through the enhancement of the VCPI eLearn Center and through the development of exceptional web-based training & resources.

#### Virginia VINE Services (Commonwealth of Virginia)

VCPI continued to administer, manage, and promote this statewide automated victim notification system that provides victims of crime with information and resources vital to their safety.

#### Virginia Sheriff's Institute Certification Program (VSI)


VCPI continued to administer this certification program in partnership with the Virginia Sheriffs' Institute, the Virginia Sheriffs' Association, and the L. Douglas Wilder School of Government and Public Affairs at VCU.

#### **COPS Office Training Portal (COPS Office)**

VCPI continued to maintain, enhance, and promote this eLearning portal housing COPS Office-funded public safety resources. Additionally, under this initiative, VCPI began development of courses on law enforcement's use of unmanned aerial vehicles, developed and launched "Supporting Your Mission: An Introduction to the Law Enforcement Officer Near Miss Reporting System", and completed "Preparing for the Unimaginable," an interactive publication.

## Pathways to Resiliency: Preventing Violent Radicalization Through Community Policing (COPS Office)

VCPI continued development of this online, national demonstration initiative depicting the efforts of law enforcement agencies in building resiliency to prevent radicalization to violence.

### **Development Intiatives**

#### National Critical Response & Recovery TTA Provider (COPS Office)

VCPI completed its work as a COPS Office National Critical Response & Recovery Training and Technical Assistance Provider. In this role, VCPI enhanced the capacity of law enforcement agencies nationwide in their response to critical incidents and emerging issues.

### Contemporary Community Policing: a National Law Enforcement Training Initiative (COPS Office)

VCPI continued this initiative supporting the advancement of community policing nationwide through the delivery of an instructor development program. To overcome challenges associated with restricted travel during the pandemic, VCPI designed and delivered the course in a virtual classroom setting, training public safety professionals from across the nation.

### A Contemporary Approach to Reimagining Effective Broken Windows (COPS Office)

VCPI continued development of an interactive learning program (including two online courses) focused on applying broken windows theory, as it was originally intended, to a broad array of modern public safety issues.


### **Enhancing Highway Safety: NHTSA Online Training Initiative (COPS Office)**

VCPI launched the development of two online courses to support the work of the National Highway Traffic Safety Administration, including "Advanced Roadside Impaired Driving Enforcement Refresher" and "Expert Insights: Testifying in Court as a Drug Recognition Expert."

#### Advancing Community Policing through eLearning (COPS Office)


