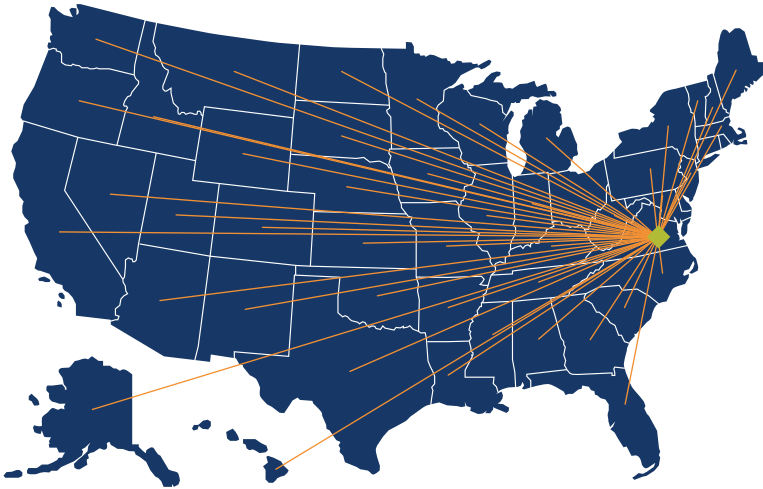

# VCPI spent much of the year developing and designing forward-thinking programs and services for public safety nationwide.

## 2017-2018 DEVELOPMENT INITIATIVES



VCPI developed **Strategic, Tactical, Resilient Interdiction of Violent Extremism (STRIVE)**, a national training program enhancing the capacity of communities to counter violent extremism through the implementation of community policing principles and practices.



VCPI launched **VINE3**, a new and enhanced platform for VA VINE, a statewide automated victim notification system, providing victims with access to a variety of new services.



VCPI is developing **Measuring What Matters: Building Trust and Legitimacy**, an online resource for law enforcement agencies nationwide focusing on the reduction of violent crime, organizational culture, officer safety and wellness, and measuring and sustaining success.



VCPI is developing **Pathways to Resiliency: Preventing Violent Radicalization Through Community Policing**, an online, national demonstration initiative depicting the efforts of law enforcement agencies in building resiliency to prevent radicalization to violence.

## OTHER 2017-2018 NATIONAL AND STATEWIDE PUBLIC SAFETY INITIATIVES



VCPI continued its work as a **BJA National Training and Technical Assistance (BJA NTTAC) Provider**, providing crime prevention training to agencies requesting services. Additionally, VCPI is now also an NTTAC Provider for BJA's new Prosecution Assessment TTA Program.



VCPI continues to support **VA VINE** and an enhancement to the VA Sex Offender Registry.



In partnership with the Virginia Sheriffs' Institute, VCPI launched and administers the **VSI Certification Program**.



VCPI is committed to expanding its support of public safety through the continuous enhancement of the **VCPI Training Portal**, the **VCPI eLearn Center**, and the development of exceptional online training and resources.



VCPI provided community policing training and support to **COPS Hiring Program (CHP)** grantees across the country through the **CHP Cohort Support: Training and Technical Assistance Program**.



VCPI serves as a **National Critical Response & Recovery TTA Provider**, enhancing the capacity of law enforcement agencies in their response to critical incidents and emerging issues.



VCPI continued to support the advancement of community policing through **Basic Community Policing Technical Assistance Program**, a national training and support initiative.

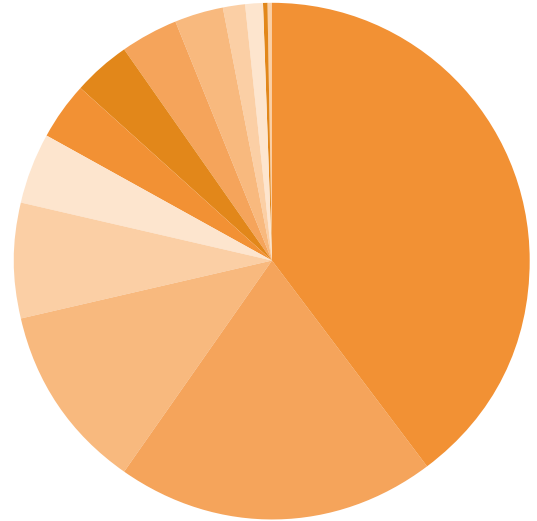

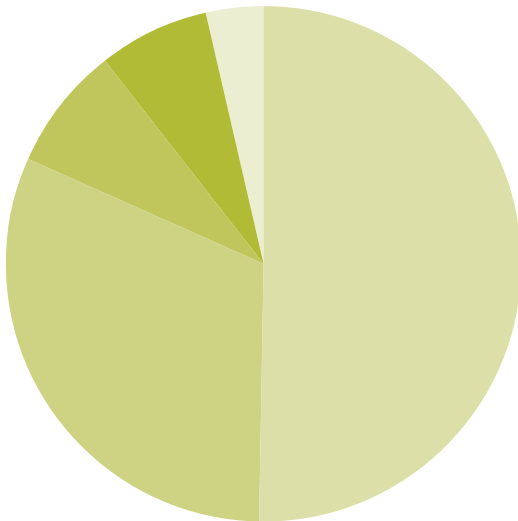
