As a nationally recognized leader in the public safety community, VCPI provides cutting-edge, online, and in-person training and technical assistance to communities in all 50 states.













## 2021-2022 Federal & State Public Safety Programs & Services

As the **COPS Office CIT National Training and Technical Assistance Provider**, VCPI launched the **Crisis Intervention Teams Adaptive System of Supports for Implementation and Specialized Training (CIT ASSIST) Resource Center**, a web-based platform supporting a variety of services for the 36 agencies across the country that received COPS Office funding for mental health crisis response initiatives in their communities. CIT ASSIST will be an ongoing, multi-year TTA program dedicated to providing assistance to their critical efforts.

VCPI continued to administer, enhance, and promote the **COPS Training Portal** housing COPS Office-funded public safety training and resources, and conducted a comprehensive assessment of this now five-year-old national public safety training platform. This year, VCPI marked a significant milestone, providing resources to nearly **27,000 public safety practitioners nationwide** and launching **seven new eLearning courses** developed by VCPI and other COPS Office training partners that address a variety of emerging public safety issues.

VCPI continued to administer, manage, and promote VA VINE, Virginia's statewide automated victim notification system that provides victims of crime with information and resources vital to their safety. This year alone, more than 82,000 new registrations were created, nearly 400,000 notifications were sent out, and nearly 2.5 million searches were conducted by victims and others seeking offender custody status information. VA VINE also includes a notification enhancement for the VA Sex Offender Registry and work began to expand VINE services to include notifications and information on protective orders.

As an official provider for the **BJA National Training and Technical Assistance Center** (**BJA NTTAC**), VCPI provides crime prevention training to agencies requesting services. Additionally, VCPI continues to be an NTTAC Provider for BJA's Prosecution Assessment TTA Program.

VCPI continued to administer the **Virginia Sheriffs' Institute Certification Program** in partnership with the Virginia Sheriffs' Institute, the Virginia Sheriffs' Association, and the L. Douglas Wilder School of Government and Public Affairs at VCU.

#### 2021-2022 Development Initiatives

VCPI continued delivery of **Community Policing: Improving Police Efficacy and Building Trust**, a COPS Office-funded national instructor development program. To overcome challenges associated with restricted travel during the pandemic, VCPI designed and delivered the course in a virtual classroom setting, training public safety professionals across the nation.

VCPI continued development of **Pathways to Resiliency: Preventing Violent Radicalization Through Community Policing**, a web-based, national demonstration initiative funded by the COPS Office depicting the efforts of law enforcement agencies in building resiliency to prevent radicalization to violence.


VCPI developed **My Voice. Our Community.**, a BJA-funded toolkit for use by agencies and communities nationwide in their own, local efforts to promote community engagement and raise awareness about the shared responsibility in reducing violent crime.

VCPI continued development of **Contemporary Approaches for Responding Effectively to Community-Defined Disorder (CARE CDD)**, a COPS Office initiative including two eLearning courses that highlight innovative practices and emphasize the collaborative role of police and other public safety partners as caretakers of their communities.

VCPI continued development of **three eLearning courses to support the work of the National Highway Traffic Safety Administration**, including "Advanced Roadside Impaired Driving Enforcement Refresher," "Expert Insights: Testifying in Court as a Drug Recognition Expert," and "Better Encounters: Police and People with Intellectual and Developmental Disabilities."


